2018 Projects Summary

2018 was a busy year for the Minnesota Association of RC&D Councils. We are featuring three of our successes as examples of how we work with partners to improve Minnesota's resources.

Hosting the National Association of RC&D Councils Biannual Meeting. MARC&D coordinated and hosted the 2018 NARC&DC Conference in Minneapolis, MN on September 22-26th. With over 120 leaders from all over the U.S. including Hawaii, New Hampshire, Florida, and Alabama, the three day conference was a success by all measures.

3rd Party Administrator for the Enbridge Ecofootprint Grant Program. MARCD is proud to partner in the Enbridge Ecofootprint Grant Program. The program provided over 3 million dollars in project funds to help protect and restore the natural environment.

Communities in North Dakota, Minnesota and Wisconsin along the Line 3 Replacement Project participated in the program.

Forty-four projects were funded to address water quality concerns, environmental issues of local concern and research. Grant recipients included Soil and Water Conservation Districts, cities, nonprofit organizations, universities, and local units of government. The average grant amount was \$69,230.

MN Women's Woodland Network. MARCD administratively supported the Minnesota Women's Woodland Network (MNWWN) over the past four years. The MNWWN recognizes and works to enhance the role of women in woodland management throughout the State. MARC&D serves as a fiscal agent for projects that complement our program objectives. In this case we provided financial services, assisted with planning efforts and provided insurance.

MARC&D was pleases to serve as the fiscal sponsor for the MN Women's Woodland Network for the past several years. They conducted numerous training events for women forest owners.
